**A RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF LEVY COUNTY, FLORIDA,
AMENDING THE FINAL BUDGET FOR FISCAL YEAR
2021-2022; PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the Board of County Commissioners of Levy County, Florida (the "Board") on September 21, 2021, held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2021-108 approving the Final Budget for Fiscal Year 2021-2022 (the "FY21-22 Budget"); and

WHEREAS, an amendment to the FY21-22 Budget is required as a result of overexpenditure of grant funds received for particular purpose(s); and

WHEREAS, pursuant to Section 129.06(2)(d), Florida Statutes, this Resolution is required in order to amend the FY21-22 Budget to receive and appropriate the unanticipated funds.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Levy County, Florida, that:

1. The FY21-22 Budget is amended as follows:

The Budget for the Water Utilities Department is amended in the amount of \$23,408, as set forth in the budget amendment form(s) attached to and made a part of this Resolution.

2. This Resolution shall take effect immediately upon its adoption.
