EMERGENCY MANAGEMENT

PARKS AND RECREATION

TRANSIT

Wilbur Dean requested on behalf of Connie Conley, Board approval of Resolution 2021-050 authorizing the execution of the 2021-2022 Transportation Disadvantaged Trip & Equipment Grant Application Agreement. The project amount for the application is \$399,118 to be reimbursed at 90%. The 10% match is paid with fares collected throughout the year.

Comm. Rooks made a motion to approve Resolution 2021-050 as requested. Second was made by Comm. Brooks and the MOTION CARRIRES.

COUNTY ATTORNEY

Requesting Board approval of the form Individual Release of Claims document ("Release") required to accompany claims for settlement payments from the class action settlement in re: Mercedes-Benz Emissions Litigation, Civil Action Number 16-cv-881, United States District Court for the District of New Jersey, and authorize the Chair to execute each Release to be submitted with the claim for each subject vehicle owned by the County.

Comm. Rooks made a motion to approve the Individual Release of Claims document and authorization for the Chair to execute each Release as requested. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

PUBLIC COMMENTS

Renate Cannon spoke of a recent law signed by Governor DeSantis concerning protests and inquired if this would apply to the Crab Fest event. Sheriff McCallum responded it would apply if there was destruction of public or business property or blocking of roads.

Isaac Smith inquired of any information concerning the Crab Fest event. Comm. Brooks responded he is aware of plans being made to continue the event in a safer location.

COMMISSIONERS' REPORTS

Comm. Brooks spoke of Legislative appropriations approved for Levy County. Comm. Brooks thanked Sheriff McCallum and his staff for managing the Crab Fest this year.

Comm. Joyner recognized Sheriff McCallum for his presentation at Law Enforcement Day. Comm. Joyner asked everyone to be aware of the farm equipment and workers driving on the roadways in Levy County, as it is watermelon harvest season.

Comm. Rooks thanked the Building & Zoning Director and the County Planner for working together to get issues taken care of quickly. Comm. Rooks also thanked Road Department employees Jessie Durrance, Casey Duquette and Lincoln Cannon who attended a meeting with her and some citizens about some road work. They were able to address the concerns expressed by the citizens and the meeting went well. Comm. Rooks thanked Road Department employees for their quick work taking care of a sinkhole she was made aware of.

Comm. Rock Meeks inquired of a start date for work on "Turkeytown" road. Mrs. LaLonde responded the process is underway of getting everything done, however, a date has not been set to start construction. Comm. Rock Meeks stated the Chiefland Watermelon Festival is scheduled for June 5th.

Comm. John Meeks spoke of the end of year school events and banquets taking place. Comm. John Meeks also gave numerous Legislative updates.
