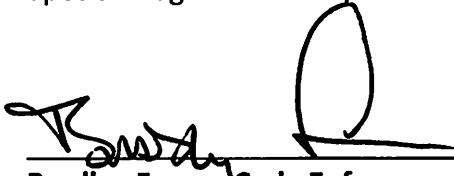
**Sec. 50-679. - Lot regulations. (b)**

- (a) *Nonconforming legal lot of record.* In any zoning district, a building permit may be issued for a structure on a nonconforming legal lot of record, provided that: the use of the structure is permitted in the zoning district; required setbacks are met; and the lot abuts a street a distance of at least 30 feet or has access via an easement serving no more than two lots and which easement connects to a public street.
- (b) *Accessory structures and uses on lots.* On lots of five acres or more in size, accessory uses and structures are allowed prior to a principal use or principal structure and may be located anywhere within the yard. On lots less than five acres in size, no accessory uses or structures are allowed until a principal structure exists on the lot and the accessory uses or structures may be located anywhere within the yard. Each accessory structure must meet required setbacks.

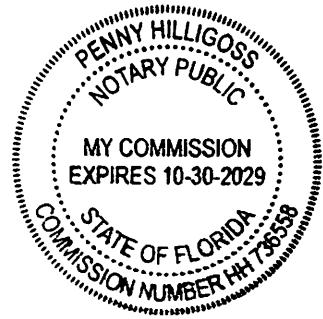

An inspection of your property located at **Parcel ID 0984800300/Williston Highlands** was made on **April 2, 2026**. This inspection revealed the following violation of Levy County Code: **Sections 34-41** and **50-679 (b)** which provides that certain conditions are not allowed on any vacant property in the county, if the conditions are visible from a public street or of other public or private property, including:

**Sec. 34-41. - Keeping unserviceable vehicles prohibited.**

(a) It shall be unlawful for any person to keep on any residential, commercial, industrial or agricultural property any unserviceable vehicle, unless such unserviceable vehicle is shielded from view, except for a vehicle temporarily stored on private real property for the purpose of repair, if the vehicle has a currently valid registration and currently valid license plate affixed thereon, and the motor vehicle is titled in the name of the owner of the property upon which the vehicle is situated or is titled in the name of the person currently residing on the premises. The term "temporarily stored" shall mean that the vehicle shall be openly stored for no more than 60 calendar days.

(b) It shall be unlawful for the owner of any land in the county to cause or permit to be stored thereon, at any location, more than two unserviceable vehicles.

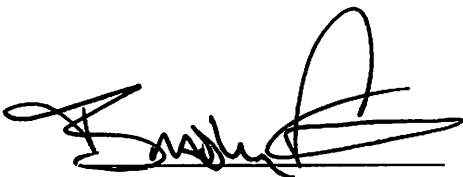
(c) Further, it shall be unlawful to store such two vehicles within the front and side yard setbacks established for the zoning district, except for the following:

**Sec. 50-679. - Lot regulations.**

- (a) *Nonconforming legal lot of record.* In any zoning district, a building permit may be issued for a structure on a nonconforming legal lot of record, provided that: the use of the structure is permitted in the zoning district; required setbacks are met; and the lot abuts a street a distance of at least 30 feet or has access via an easement serving no more than two lots and which easement connects to a public street.
- (b) *Accessory structures and uses on lots.* On lots of five acres or more in size, accessory uses and structures are allowed prior to a principal use or principal structure and may be located anywhere within the yard. On lots less than five acres in size, no accessory uses or structures are allowed until a principal structure exists on the lot and the accessory uses or structures may be located anywhere within the yard. Each accessory structure must meet required setbacks.
- (c) *Corner lots.* At all street intersections, no obstruction to vision (other than an existing building, post, column or tree) exceeding 30 inches in height above the established grade of the street at the property line shall be erected or maintained on any lot within the triangle formed by the street lot lines of such lot and a line drawn between the points along such street lot lines 30 feet distant from their point of intersection.

It is **mandatory** that you contact the Code Enforcement Officer at (352) 486-5541 within **Five** days to discuss the actions needed toward compliance so that the violations can be resolved. Failure to vacate the vehicle and the semi-trailer off the lot by **April 30th, 2026** will result in a Special Magistrate Hearing being held on **MAY 20, 2026** where daily fines can be ordered as long as the property stays in noncompliance.
