**A RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS OF LEVY COUNTY, FLORIDA,  
AMENDING THE FINAL BUDGET FOR FISCAL YEAR  
2021-2022; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Board of County Commissioners of Levy County, Florida, (“the Board”) on September 21, 2021 held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2021-108, adopting the Final Budget for Fiscal Year 2021-2022; and

**WHEREAS**, an amendment to the 2021-2022 Final Budget is required as a result of unanticipated funds received in the 2021-2022 Final Budget and received for particular purpose(s); and

**WHEREAS**, on October 5, 2021, the Board considered this Resolution pursuant to the provisions of Section 129.06(2)(d), Florida Statutes, in order to amend the Fiscal Year 2021-2022 Final Budget to reflect the changes required; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Levy County, Florida, that:

1. The Fiscal Year 2021-2022 Final Budget adopted by Resolution 2021-108, is hereby amended as follows:

The Transportation Budget shall be increased by \$91,515.00, as reflected in the attached budget amendment form.

2. This resolution shall take effect immediately upon its adoption.
