PUBLIC INFORMATION OFFICER

Mary-Ellen Harper presented and requested approval of the Draft Levy County Public Information Strategic Plan.

PROCUREMENT

B. Requesting Board approval of Task Assignment 2024-3 between Levy County and Menadier Engineereing, LLC for the Bird Creek Boat Ramp Improvements, Phase II in the amount of \$66,380. This project is to construct two (2) covered pavilions and 1,320 square feet of boardwalk. The grant amount received for funding of this project is \$464,080.

Comm. John Meeks made a motion to approve Task Assignment 20214-3 as requested. Second was made by Comm. Hodge and the MOTION CARRIES.

BUILDING DEPARTMENT

David Meyer spoke to the Board and requested direction regarding a piece of property donated to the Children's Table be used as a Community Garden. They are requesting permitting for electric to water the garden, however, per Code his office cannot issue a permit for electric unless a building is to be constructed. The property size is 4+ acres and is located in a deeded subdivision. If the property had Ag. Exemption, this would not be an issue, but it does not.

Property Appraiser, Jason Whistler and Atty. Shalley spoke regarding this item.

Audience member, Renate Cannon suggested contacting other counties in Florida of how they handle situations similar to this.

Following discussion, consensus was given to direct Atty. Shalley to work on changes to the County Ordinance amending the Code dealing with this type of agriculture use.

PUBLIC HEARING PLANNING & ZONING

Quasi-Judicial Hearing for Petition No. SE 23-01 continued from February 6, 2024: Requesting Board review of the Final Order for Special Exception Petition SE 23-01 for Major Mining to ensure it is consistent with the approval of the petition on February 6, 2024.

Petition No. SE 23-01: Douglas VanDeursen, Engineer repre3senting Ryan Thomas for 3RT Sand Mine requesting Special Exception for a major mining operation pursuant to Sec. 50-719, Mining and Excavation of Minerals, Resources, or Natural Resources, and Site Reclamation of the Levy County Land Development Code to allow a Sand Mine (no blasting or fracking) on approximately 1,100 acres (includes mine property and access to CR 337) of land located in Section 35, Township 12S, Range 17E; Levy County, Florida. These parcels are located in Agricultural/Rural Residential (A/RR) and Rural Residential (RR) Land Use and Zoning District.

Parcel Number(s): 0359701600, 0359700400, 0359700000, 0359700300, 0360400600, 0360400000, 036040040B, 036040040A, 0360400400, 0360400500, 0360600500, 0360600300, 0360600000, 0359400000, and 0359200000.

A statement was read into public record by Jeffrey and Karen Ferguson in opposition of the 3RT Sand Mine Special Exception. Audience member Robbie Blake also spoke against the 3RT Sand Mine Special Exception.

Comm. Rock Meeks made a motion to approve Petition No. SE 23-01 with changes/additions as stated. Second was made by Comm. Brooks and the MOTION CARRIES.

PUBLIC COMMENTS

Audience member Stacy Peters requested the Board hear the remainder of the Ferguson's statement, as it had gone over the 3 minute time limit. Mrs. Ferguson completed the reading of the statement she and her husband had prepared opposing the approval of the 3RT Sand Mine Special Exception.

COMMISSIONERS' REPORTS

Comm. Rock Meeks reminded everyone of the Suwannee River Livestock Show and Fair taking place this week.

Comm. John Meeks reminded everyone to vote today for their Presidential preference. There will be a Job Fair taking place at the First Baptist Church in Bronson on Thursday. The Chiefland Rotary Club Fishing Tournament as well as the Wild Hog Canoe/Kayak Race will take place on Saturday, April 20th.

Comm. Brooks commended the youth for their efforts and work with the animals in the fair. Comm. Brooks stated Bill Brown will be speaking at the Community Garden location on Thursday of the plans for this project, if any are interested to attend.

Comm. Mills reminded everyone of the Williston Woman's Club Casino Night coming up on April 27th.
