1. The Fiscal Year 2019-2020 Final Budget adopted by Resolution 2019-078, is hereby amended as follows:

The Supervisor of Elections General Fund Budget shall be increased by \$56,488.00, as reflected in the attached budget amendment form.

2. This resolution shall take effect immediately upon its adoption.
