We appreciate the time you have taken to participate in the rewrite of the Levy County Comprehensive Plan. A comprehensive plan is often described as a “blueprint for the future”. The Plan is a general, long-range (10-20 year), policy and implementation guide for decisions concerning the overall growth and development of the County.

Levy County’s Comprehensive Plan was first adopted in 1990 with a sunset date of 2026. The plan is updated every seven years and was last updated in 2016. While updating the Comprehensive Plan for the 2024 deadline it was evident, with a sunset date of 2026, that it was time to embark on a rewrite of the plan for the next 10-20 years for Levy County. This task involves identifying major issues for the County, with citizen input, and then addressing those major issues within the Comprehensive Plan.

During the past 10 years, Levy County has grown from a population of 40,304 to a population of over 45,000, growing at a rate of 1.2 % per year. While stopping growth is neither possible nor practical, we can direct where and how growth occurs. The current Comprehensive Land Use Plan plays a major role in how Levy County grows. Your input in the rewrite of the current comprehensive plan will help the County to focus on specific issues that affect growth and development in the County.
