 - **Discussion:** Funding is available in the 2024-2025 budget if the Board wishes to approve this request. Brush 75 is primarily used by the Cedar Key Fire Department for off-island wildfires in the unincorporated areas around Cedar Key.
 - Chief Robert Robinson, Cedar Key Fire Rescue Remarks: We have a brush truck in service now to work the unincorporated areas but it has no radio. This funding will secure the radio needed for communications between Cedar Key and other first responding county agencies.

- 3. To approve the State Aid to Libraries Grant Agreement between the State of Florida, Department of State and Levy County Board of County Commissioners for and on behalf of the Levy County Public Library System, in the amount of \$59,507.00.

 - **Discussion:** Grant funds shall be used for the operation and maintenance of the library. The allowable budget categories are: Personnel Services (salaries, wages, and related employee benefits provided for all persons employed by the reporting entity whether on fulltime, part-time, temporary, or seasonal basis); Operating Expenses (expenditures for goods and services which primarily benefit the current period and are not defined as personal services or capital outlays);

Non-Fixed Capital Outlay (outlays for the acquisition of or addition to fixed assets); and Other (other operating expenditure categories in the library budget). Operating: \$3,188.00 Equalization Grant: \$56,319.00 Total State Aid Funding to be awarded in the amount of \$59,507.00.

New mowers are commercial grade and older mowers to be surplused and auctioned or used for parts.
