## RESOLUTION NUMBER 2023-29

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, AMENDING THE FINAL BUDGET FOR FISCAL YEAR 2022-2023; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Levy County, Florida on September 20, 2022, held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2022-55 approving the Final Budget for Fiscal Year 2022-2023 (the "FY22-23 Budget"); and

WHEREAS, pursuant to Section 129.06(2), Florida Statutes, this Resolution is required in order to amend the FY22-23 Budget.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Levy County, Florida, that:

1. The FY22-23 Budget is amended as follows:

The Misc Grants Fund (Fund No. 115) is increased by \$127,836 due to receipt of additional revenue from an E911 State Grant for annual GIS maintenance and those additional revenues are appropriated as set forth in the budget amendment form attached to and made a part of this Resolution.
