Pursuant to the Bylaws of the Florida Association of Counties, please find this certified letter as notification that a vacancy on the FAC Board of Directors for District 9 exists due to Commissioner John Meeks having been elected to FAC 2nd Vice President during the 2024 FAC Annual Conference.
