

COUNTY DEED



THIS DEED, made the 5 day of 2007, by Levy County, Florida, a political subdivision of the State of Florida, whose mailing address is P.O. Box 310, Bronson, Florida 32621, party of the first part, and the City of Cedar Key, a Florida municipal corporation, whose mailing address is P.O. Box 339, Cedar Key, FL 32625 party of the second part;

WITNESSETH, that the said party of the first part, for and in consideration of the sum of \$10.00 (Ten and 00/100 Dollars) to it in hand paid by the party of the second part, receipt whereof is hereby acknowledged, has granted, bargained and sold to the party of the second part, his or her heirs and assigns forever, the non-bridge right -of-ways lying and being in Levy County, Florida, depicted on the maps attached hereto as Exhibit "A" and more particularly described as follows:

Levy County Road 457, a/k/a Andrews Circle, for the entire length of such road shown as Andrews Circle on the subdivision plat of Cedar Key Shores, Unit No. 1, recorded in Plat Book 3, Page 19, of the public records of Levy County, Florida; and

Levy County Road 459, a/k/a "H" Street, from the north right-of-way line of 7th Street to the intersection with the southwest right-of-way line of Whiddon Avenue, as shown in part on the Map of the Southern Part of the City of Cedar Key, recorded in Plat Book 1, Page 3, of the public records of Levy County, Florida; and


