### Doug and Ali

Clayton Bratcher indicated that during demolition they found the galvanized water lines in the CMU walls and one line was damage during demolition. They were unable to find a shut off valve outside the building and had to shut the water off to several buildings within the complex. Clayton said that the existing  $1 - \frac{1}{2}$ " galvanized water line under the concrete floor slab runs through the concrete foundation but they cannot find where it exits the building outside the building and is connected to a meter or shut off valve. The galvanized pipes appear to be the original water supply lines installed in the 1970's and the existing water line under the slab tees off to the restrooms at the current Zoning Department and to the current restrooms at the opposite end of the building.

Attached is a change order proposal to install a new 1 -1/2" copper water line above the ceiling to service the two restrooms and conference room at the Development Department. This will allow the restrooms and conference room to be served over head and a future connection will be included to connect to a new water line outside the building if the existing water line begins to leak. At this time, the water supply main has not been found outside of the building. The overhead 1-1/2" pipe will also have Tees to connect to the Zoning department restrooms and the restrooms at the south side of the building, which is now county staff offices, in the future, should the below slab galvanized piping fail . A shut off valve will be installed to shut down the building in the future. A portion of the existing galvanized under slab piping will remain active for the two remote restrooms until there is a leak in the existing piping and the water supply lines can be installed overhead. The Change Order cost is \$8,304.00.

Our other option is to proceed with the plumbing as is and connect to the existing galvanized pipe under the concrete slab. Should the existing galvanized pipe fail then installation of a new water line overhead within the building will cost much more due to the build out of the office space.

My recommendation is to install the new 1-1/2" copper pipe currently while the building is open for demolition and there is easy access above the ceiling. Also install a main shut off valve and tees for future connection to the non-renovated restrooms.


