**WHEREAS**, an amendment to the 2020-2021 Final Budget is required as a result of unanticipated funds received in the 2020-2021 Final Budget and received for particular purposes(s); and

**WHEREAS**, on September 7, 2021, the Board considered this Resolution pursuant to the provisions of Section 129.06(2)(d), Florida Statutes, in order to amend the Fiscal Year 2020-2021 Final Budget to reflect the changes required; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Levy County, Florida, that:

1. The Fiscal Year 2020-2021 Final Budget adopted by Resolution 2020-106, is hereby amended as follows:

The Emergency Management Budget shall be increased by \$997.00, as reflected in the attached budget amendment form.

2. This resolution shall take effect immediately upon its adoption.
