

**RESOLUTION  
NUMBER 2023-47**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF  
LEVY COUNTY, FLORIDA, ADOPTING THE PROPOSED MILLAGE  
RATE FOR LEVY COUNTY FOR THE FISCAL YEAR COMMENCING  
OCTOBER 1, 2023 AND ENDING SEPTEMBER 30, 2024, AND  
PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, after a series of budget workshops/meetings held May through July of 2023 with presentations by Finance Staff in the Clerk and Comptroller's Office (who serves as the County's Budget Officer per Resolution Number 2017-015), on August 1, 2023, the Board of County Commissioners (the "Board") approved a tentative budget and a proposed millage rate for the purpose of providing notice and setting the public hearings required by Section 200.065, Florida Statutes; and

**WHEREAS**, on this day, the Board held a public hearing after 5pm to consider this Resolution and to consider Resolution Number 2023-48 to adopt the tentative budget; and

**WHEREAS**, the gross taxable value for operating purposes not exempt from taxation within Levy County has been certified by the County Property Appraiser to the Board as \$2,816,148,642.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Levy County, Florida, that:

1. The Fiscal Year 2023-2024 proposed countywide operating millage rate is 9.0000 mills, which is more than the rolled-back millage rate of 8.2062 mills by 9.67%.
2. The County has no voted debt service millage.
3. This Resolution shall take effect immediately upon its adoption.
