**A RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF LEVY COUNTY, FLORIDA,
AMENDING THE FINAL BUDGET FOR FISCAL YEAR
2021-2022; PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the Board of County Commissioners of Levy County, Florida (the "Board") on September 21, 2021, held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2021-108 approving the Final Budget for Fiscal Year 2021-2022 (the "FY21-22 Budget"); and

WHEREAS, pursuant to Section 129.06(2), Florida Statutes, this Resolution is required in order to amend the FY21-22 Budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Levy County, Florida, that:

1. The FY21-22 Budget is amended as follows:

\$47,121 is appropriated from the reserves of the Capital Projects and Replacement Fund (Fund No. 301) in order to increase the specified expenditures in that Fund for the purpose of purchasing a vehicle, as set forth in the budget amendment form(s) attached to and made a part of this Resolution.

2. This Resolution shall take effect immediately upon its adoption.

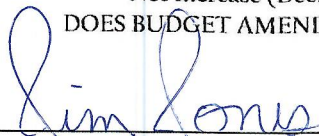

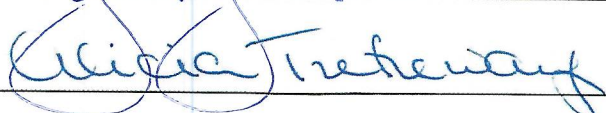
