NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Levy County, Florida, that:

1. The Fiscal Year 2020-2021 Final Budget adopted by Resolution 2020-106, is hereby amended as follows:

2. The Repair/Maint-Bldg/Grounds budget shall be increased by \$100,000.00, as reflected in the attached budget amendment form.

3. This resolution shall take effect immediately upon its adoption.
