## RESOLUTION 2020-115

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF LEVY COUNTY, FLORIDA, AMENDING THE SUPERVISOR OF ELECTIONS GENERAL FUND OF THE FINAL BUDGET FOR FISCAL YEAR 2020-2021; PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Board of County Commissioners of Levy County, Florida, ("the Board") on September 22, 2020 held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2020-106, adopting the Final Budget for Fiscal Year 2020-2021 ("2020-2021 Final Budget"); and

**WHEREAS,** pursuant to Section 129.201(7), Florida Statutes, the 2020-2021 proposed budget of the Levy County Supervisor of Elections was submitted to the Board, approved by the Board, and included in the 2020-2021 Final Budget; and

WHEREAS, pursuant to Section 129.201(8), Florida Statutes, the budget items of the a county supervisor of elections placed in the annual budget of the county are subject to the same provisions of law as those that apply to the annual budget of that county, however an amendment to the appropriations of the county supervisor of elections may not be made without due notice of the change to given to the county supervisor of elections; and

WHEREAS, an amendment to the Supervisor of Elections General Fund of the 2020-2021 Final Budget is required as a result of unanticipated funds received by the Levy County Supervisor of Elections for the 2020-2021 fiscal year and received for a particular purpose; and

**WHEREAS**, the Levy County Supervisor of Elections has been provided due notice of the change required to the Supervisor of Elections General Fund of the 2020-2021 Final Budget as the result of the receipt of unanticipated funds for a particular purpose; and

**WHEREAS,** on October 20, 2020, the Board considered this Resolution pursuant to the provisions of Section 129.201, Florida Statutes, and Section 129.06(2)(d), Florida Statutes, in order to amend the Supervisor of Elections General Fund of the 2020-2021 Final Budget to reflect the changes required; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Levy County, Florida, that:
