

**TASK ASSIGNMENT 2023-07 AGREEMENT FOR ENGINEERING AND RELATED SERVICES FOR WATER UTILITIES**

THIS TASK ASSIGNMENT is issued by LEVY COUNTY, a political subdivision of the State of Florida (the "County") to WRIGHT-PIERCE, INC., (the "Consultant"), pursuant to the Agreement between Levy County and Wright-Pierce, Inc., for Engineering and Related Services for Water Utilities dated August 22, 2023 (the "Engineering and Related Services for Water Utilities Agreement") for University Oaks, Phase IV Water Main Improvements (the "Project" or "project") funded by the Suwannee River Water Management District (referred to as "SRWMD" for the purposes of this Task Assignment).

1. Scope of Services. Pursuant to the provisions of the Engineering and Related Services for Water Utilities Agreement and this Task Assignment, Consultant shall provide all of the services and materials described in Exhibit "A" Project Description and Scope of Work ("Scope of Work"), attached hereto and by this reference incorporated herein, at the level of workmanship and quality set out in the Engineering and Related Services for Water Utilities Agreement.

2. Proposal. Consultant submitted a proposal for the Project dated August 3, 2023, which is attached hereto (the "Proposal"). The proposal is divided into Consultant's proposal narrative, fee proposal submitted to County which consists of 6 pages. All 6 pages of the Consultant's Proposal dated August 3, 2023, are incorporated herein by this reference.

3. Compensation. County shall compensate Consultant for its services pursuant to this Task Assignment a not to exceed amount of Sixty-Five Thousand Five Hundred Fifty-Four dollars (\$65,554.00) in accordance with the fee set forth in the Proposal. Invoices for payments and payment to the Consultant shall be made in accordance with the Florida Local Government Prompt Payment Act, Sections 218.70 through 218.79, Fla. Stat.

4. Additional Provisions.

A. In addition to any other provisions of the Engineering and Related Services for Water Utilities Agreement and the Scope of Services, Consultant shall comply with all of the provisions of Suwannee River Water Management District Memorandum of Agreement for Cost share Assistance dated December 27, 2021 concerning Contract 21/22-034 ("MOA"), related to the Scope of Work to be provided by Consultant, and which are assignable or applicable to Consultant in the provisions of its services to County herein. The MOA Agreement is incorporated herein by this reference.

5. In the event of a conflict between these documents setting obligations pursuant to this Task Assignment or incorporated into this Task Assignment, the documents will be given precedence in the following:

First: The SRWMD MOA;

Second: This Task Assignment;

Third: The Scope of Work in Exhibit "A"

Fourth; The Engineering and Related Services for Water Utilities Agreement.

All other terms of the Engineering and Related Services for Water Utilities Agreement not in conflict with the SRWMD MOA Agreement or this Task Assignment shall apply to Consultant’s services to be provided under this Task Assignment and the County’s obligations under this Task Assignment.
