**A RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS OF LEVY COUNTY, FLORIDA,  
AMENDING THE FINAL BUDGET FOR FISCAL YEAR  
2022-2023; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, on September 20, 2022, the Board of County Commissioners of Levy County, Florida held a public hearing as required by Section 200.065, Florida Statutes, and adopted Resolution 2022-55 approving the Final Budget for Fiscal Year 2022-2023 (the "FY22-23 Budget"); and

**WHEREAS**, pursuant to Section 129.06(2), Florida Statutes, this Resolution is required in order to amend the FY22-23 Budget.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Levy County, Florida, that:

1. The FY22-23 Budget is amended as follows:

\$100,000 is transferred from investment earnings in the General Fund (Fund No. 001) in order to increase the specified expenditures in that Fund for the purpose of Investment Management Company services, as set forth in the budget amendment form attached to and made a part of this Resolution.

2. This Resolution shall take effect immediately upon its adoption.
