**A RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF LEVY COUNTY, FLORIDA, TO
ADVERTISE THE HEARING FOR THE VACATION,
ABANDONMENT, AND CLOSURE OF A PORTION OF NE
27TH STREET, LOCATED IN LEVY COUNTY, FLORIDA.**

WHEREAS, the Board of County Commissioners of Levy County, Florida (“the Board”), desires to consider the vacation of a portion of a public road in Levy County, Florida; and

WHEREAS, the roadway sought to be vacated, abandoned and closed is described as follows:

A portion of NE 27th Street from the East right of way line of NE 118th Terrace to the West right of way line of NE 120th Avenue, located in Green Hills Subdivision, a subdivision recorded in Plat Book 8, Page 13, Public Records of Levy County, Florida.

WHEREAS, it has been represented to the Board that the closing and abandoning of the above-described roadway will not adversely affect the ownership or right of convenient access of any property owner in the immediate area.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Levy County, Florida that a public hearing on the proposed closing of the above-described roadway in Levy County, Florida, be scheduled for Tuesday, August 3, 2021, at 9:00 A.M., or as soon thereafter as it may be heard, and that proper legal notice of said hearing be published according to the laws of the State of Florida.

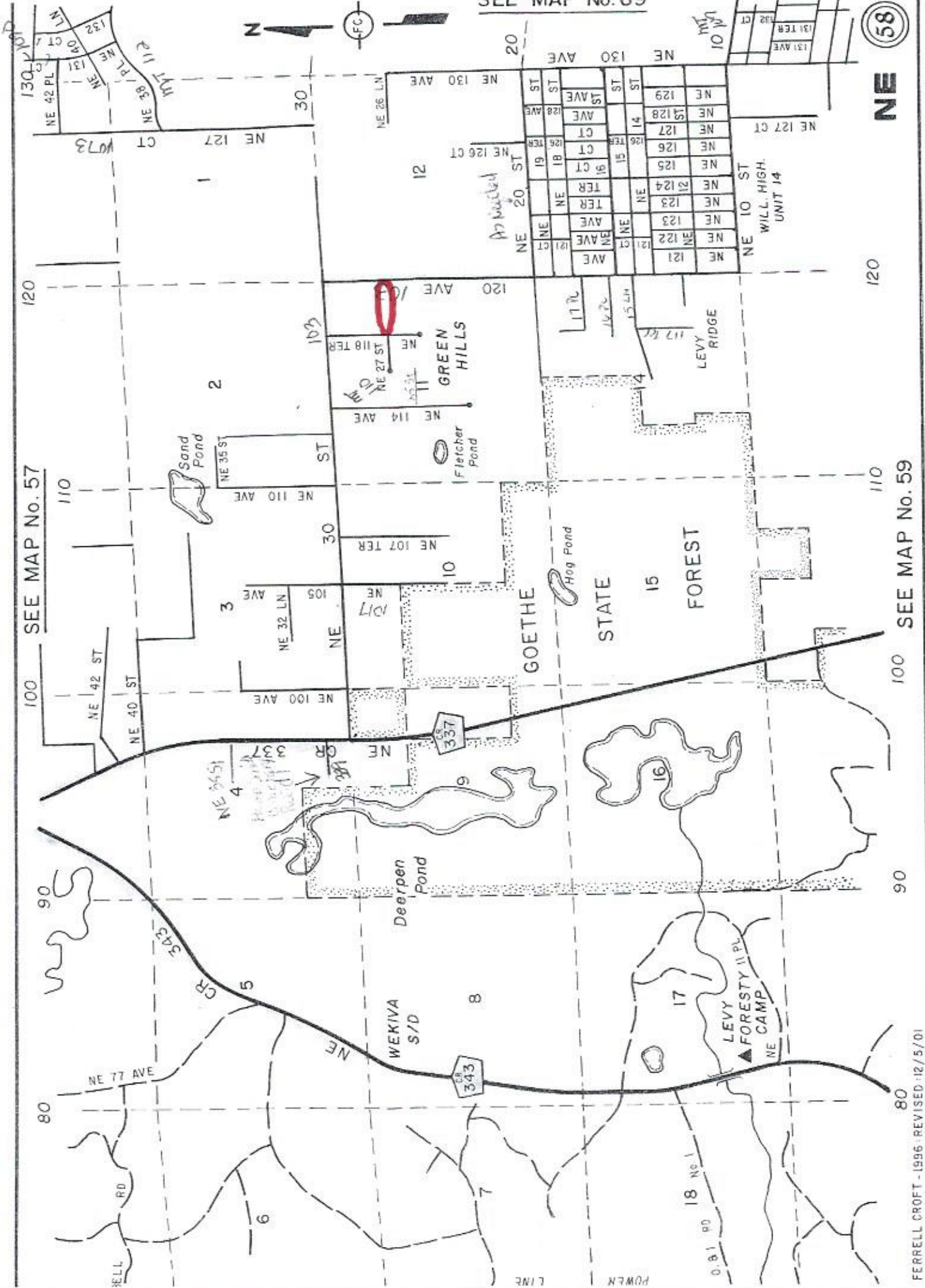
NOTICE OF INTENT TO CONSIDER VACATING PUBLIC ROAD
