## III. New Business - Director, Stacey Hectus

- 1. **Establishing a County Vision with measurable goals** geared towards prioritizing rural county sustainability and fiscally conservative governance focusing on the following areas:
  - A. **Agricultural Land Preservation:** Methods and strategies for encouraging and incentivizing agricultural land preservation. The key to positive engagement will be creating a program or programs which strongly encourage but do not require participation.
  - B. **MSD Strategy Review:** optimizing utilization of municipal service district to better serve the needs of the community.
  - C. State of Florida Overreach
  - D. Major Roads Infringement
  - E. Agrotourism
  - F. **Future Growth:** Proposed water & sewer connection between the Western towns of Levy County and Bronson or Chiefland is a healthy thing for the environment and residents, but it will create growth. Do we want urban sprawl along those utility lines if they are developed?
  - G. Growth in Services Depending on the turnpike extension and the water / sewer system expansion, is there some sort of future planning for population growth? This is to consider the services that will be needed, roads, schools, etc. 5 years / 10 years / 20 years, etc.
  - H. **Hospital** there is definite need for a hospital, or at least an ER facility connected to the one or more of the hospital systems in Gainesville. How to encourage that with incentives?

I. Public Transportation-long-term inter-county public transportation will need to be upgraded, but currently, a present need is for transportation services for residents of Levy County who work in Gainesville to the three major hospitals, UF, etc. This would be good for both the residents of Levy County and the major employers in Gainesville. Hopefully, the funding would be primarily by the Gainesville employers with cooperation from Levy County providing the pickup parking areas. This would benefit people who either choose not to drive into Gainesville, or cannot afford to do so and would help by providing quality employees from Levy County. This is an economic development opportunity to increase income opportunities for citizens of Levy County. It would be environmentally sustainable and help relieve major traffic congestion by not having to individually drive, park, etc. We can explore a sort of agreement with those institutions with several pickup points in Levy County.
