The Public Works Committee of the Lincoln Parish Police Jury met in the Police Jury Meeting Room, 100 West Texas Avenue, Tuesday, May 9, 2023, at 6:30 p.m. Present were: Logan Hunt, Chair; Theresa Wyatt, TJ Cranford, Glenn Scriber, and Matt Pullin.

Logan Hunt called the meeting to order and Matt Pullin delivered the invocation.

Matt Pullin offered a motion, seconded by Theresa Wyatt, to approve the agenda. The motion carried with the following votes:

Chairman Hunt called for Public Comments on Agenda Items. There were none.

Matt Pullin offered a motion, seconded by TJ Cranford, to recommend accepting the low bid of Kenworth of Louisiana in the amount of \$123,980.00 for a 6/8 yard dump truck.
