Dear Mr. Durrett and Mr. Postel:

We respectfully request the following be considered for funding in the budget of 2022 of the Lincoln Parish Police Jury, to-wit:

- 1. Funding be continued for the court reporters, Sara Jo Hood and Weita Gaskin for 2022; if there is a cost of living raise given to employees of the Lincoln Parish Police Jury that they also be given that cost of living raise. We request also that the court reporter's retirement and insurance benefits be paid. If this has not been paid in the past, our office should be reimbursed for the amounts not paid. We also request that when a court reporter is ill or all court reporters are in court with their judge and we have to hire a court reporter to fill in on an Ad Hoc/ProTempore case that they get paid by the Police Jury.
- 2. A reminder that the Court Reporter equipment needs continual repairing and updating for the future and possibly replaced in all three courtrooms when needed.
- 3. Renovate balcony in Courtroom #1 so that it can be utilized to afford more space for social distancing for jury selection and trials.
- 4. We are requesting that our office receive funds from the American Rescue Plan Act of 2021 that has been sent to your office for distribution. The Treasury is launching this much-needed relief to:
  - Replace lost public sector revenue to strengthen support for vital public services and help retain jobs. (this section qualifies the Judges' Office)
