An Ordinance to Participate in the Local Health Care Provider Participation Program

WHEREAS, Lincoln Parish Police Jury passed Ordinance No. _____ on _____ for the purpose of financing state and local healthcare expenditures under Medicaid through a Local Health Care Provider Participation Program pursuant to the 2020 La. Act 330, codified at La. R.S. 40:1248.1 through 1248.12;

WHEREAS, the Lincoln Parish Police Jury designated a committee to gather the appropriate Medicaid cost reports from those taxpayers subject to the assessment to determine the appropriate assessment; and

WHEREAS, the committee has reported its research and conclusions.

NOW THEREFORE, BE IT ORDAINED that the Lincoln Parish Police Jury enacts the following Ordinance amending Ordinance No. _____, codified at Chapter _____, Article _____ - Local Health Care Provider Participation Program, Section _____ as follows:
