Executive Summary

This Interlocal Agreement (ILA) with the City of Shoreline provides Lake Forest Park residents access to Shoreline Parks & Recreation programs. Through a special early registration day, LFP residents access the registrations as if they were Shoreline residents and do not pay an extra-territorial rate. In the updated ILA, the special registration day continues, and LFP residents will get an 8% discount regardless of when they register. This agreement will last three years then be reevaluated once City of Shoreline is further along on the future aquatic center.

Background

The City of Lake Forest Park has had a recreation services contract with the City of Shoreline since 2006 to provide Lake Forest Park residents with discounted rates to Shoreline's recreation services and

facilities. In exchange, a single day early sign-up for each recreation season was offered, at the Shoreline resident rate. Sign-ups outside that day were at the standard out-of-city rate, which trends at 10-15% above the in-city rate. Also, LFP promised to use its electronic and print systems to promote the availability of Shoreline Recreation programs.

Staff Recommendation
