Funding Outlook


Secured 80% of necessary funding

Est. gap of 20% (prospective, contingent, and remaining)

Identified potential funding of 20% (from 2026 King County Levy)

Anticipated gap at 2026 RCO deadline: LOW \$482, HIGH \$40K

\$12.9M **Total Project Cost** Soft Costs \$4.0M Construction Costs \$8.9M 70% Design (07/2025)Design Contingency 10%



Funding Outlook

Secured funding: \$10.39M (80%)

Prospective funding: \$2.54M (20%)

Project cost: \$12.93M

City contributions: \$1.4M / 11%, (existing design contracts, inc. site assessments and permitting)

Grants: \$11.54M / 89%, (state, county funds for construction phase)

Design and construction is projected to be fully funded.

Confirmation of final funds is anticipated in January 2026.

Options for backup funding, if needed:

- 2026 RCO application (May 1, 2026)
- Community fundraising
 - Sponsorship or donations for design elements (i.e., trees, benches, bricks, playground equipment, etc.)
 - Community donations could be used to support future O&M costs

O&M Cost Estimate

Estimate of annual operations and maintenance cost, including staff labor hours

Should be reviewed against current operating costs for similar/like facilities (i.e., city hall, other parks)

Long-term costs are for planning, may not reflect actual replacement needs

Grants and outside funds may be available to support planned improvements and other costs

Operations & Maintenance Cost Forecast

Target Ribbon Cutting: May 2027

Annual O&M Cost Estimate (Years 1-5)

Year	Est. Annual O&M Cost	Notes	
Year 1 (partial)	\$93,333	Full annualized O&M cost = \$160,000 — Prorated for 7/12 months = \$93,333 — Excludes utilities.	
Year 2	\$165,600	3.5% escalation from Year 1 full annual cost, excludes utilities.	
Year 3	\$171,396	3.5% YOY escalation.	
Year 4	\$177,395	3.5% YOY escalation.	
Year 5	\$183,604	3.5% YOY escalation.	

Year 1 Cost Basis:

- Buildings: 2,922 SF × \$3.25/SF/year = \$9,496
- Site Improvements: 88,350 SF × \$0.75/SF/year = \$66,263
- Additional annual maintenance contracts (janitorial, landscaping, repairs) = \$84,241
- Subtotal = \$160,000 prorated for 7/12 months = \$93,333

Assumptions:

- Annual O&M includes custodial, landscaping, general repairs, janitorial, supplies, and seasonal maintenance.
- Based on a blended rate of \$3.00–\$3.50 per SF per year for buildings and \$0.50–\$1.00 per SF per year for site improvements.
- Utilities excluded per city direction.

Planned Long-Term Maintenance Forecast

Est. Year	Est. Annual O&M	Est. Add'l Expenses	Notes
Year 10	\$218,064	\$100,000	Breakout: \$40,000 interior repaint, \$20,000 deck refinishing, \$25,000 HVAC major service, \$15,000 appliance replacement.
Year 15	\$258,992	\$150,000	Breakout: \$60,000 restroom fixture replacement, \$40,000 selective interior upgrades, \$50,000 exterior touch-up and sealing.
Year 20	\$307,601	\$180,000	Breakout: \$180,000 for resurface and restripe parking areas.
Year 25	\$365,333	\$450,000	Breakout: \$450,000 for roof replacement of major facilities including structural inspection and minor repairs.


