## A RESOLUTION OF THE CITY COUNCIL OF LOGANVILLE CENSURING COUNCIL MEMBER ANNE HUNTSINGER

WHEREAS, members of the City Council of Loganville are duly elected officials entrusted by the pubic to faithfully execute their duties in accordance with the Constitution, the laws of the State of Georgia, the City Charter, and the Council's Policy on Procedures and Protocols; and

WHEREAS, Executive Sessions and attorney client privilege are authorized by law for limited purposes, including but not limited to the discussion of legal, personnel, and other sensitive matters, and the confidentiality of such sessions and work products is crucial to protect the interests of the City and its residents; and

WHEREAS, all members of the City Council are bound by their oath of office and applicable law to maintain the confidentiality of executive session discussions and confidential materials and work products; and

WHEREAS, in 2021, Council Member Huntsinger published on her social media and campaign website, "LoganvilleStrong.com", confidential information that was confidential work product, as well as shared in Executive Session of the Council which she was seated; and

WHEREAS, the information Ms. Huntsinger freely published had been requested via the Open Records Request process multiple times, by multiple citizens. Each request was denied by the city's official record keeper, City Manager Danny Roberts. Mr. Roberts consulted with legal counsel and based his refusal of production of requested documents as being protected under O.C.G.A. section 50-18-72(a)(41) and (42) (see attached Exhibit A); and

WHEREAS, the City Council of Loganville has a duty to hold its members accountable for violations of trust and to preserve the integrity of its processes on behalf of the residents it serves;

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF LOGANVILLE, that:

- 1. The City Council hereby formally censures Council Member Anne Huntsinger for publishing confidential materials and work product, as well as executive session privilege.
- 2. This Resolution of Censure constitutes the Council's official expression of disapproval of Council Member Huntsinger's conduct and condemnation of the violation of confidentiality and trust inherent therein.
- 3. The Council reaffirms its commitment to maintaining the confidentiality of attorney client privilege, as well as executive sessions, assuring that information is shared with the public only through lawful and appropriate channels, and upholding the standards of ethical conduct required of elected officials.

4. Council member Huntsinger is strongly admonished to refrain from further breaches of confidentiality and is urged to conduct herself in a manner that preserves public confidence in the City Council of Loganville.
