Hi Art - Please forward this other public comment below to the Complete Streets commissioners. Thank you.

Before giving a recommendation to the city council, I encourage you to poll all impacted residents (i.e., residents who live where the new parking restriction would be imposed, residents who live within a block or two who might be indirectly impacted by school parking that might be pushed to their streets, and residents where the current restrictions are being imposed on Merritt and Valencia and other streets) in order to determine if at least a simple majority of residents are in favor or against any newly proposed parking restrictions.

The poll, however, should be sufficiently detailed and specific about the proposed parking restriction policy so that residents understand how this might impact them (Ex., signs near or in front of their houses and not being allowed to park on the street during the restricted hours and visitors not being able to park on the street during restricted hours).

When I helped organize my section of Panchita Way to have a single-story overlay, the city required us to have a 2/3 majority to approve the single story overlay. The process was rigorous and the vote was conducted by the city. I also propose you recommend to the city council that the city conduct a vote by impacted residents to determine if a 2/3 majority of residents approve before they vote on the parking restrictions.

Hello,

My husband and I reside at 75 N Gordon Way, Los Altos, CA 94022, which is 3 blocks from Los Altos High School. Due to the current parking restrictions that are already in place within 1 block of the high school on North Gordon Way, up to Angela Court, the staff and students currently use up all the parking spaces in front our house, starting at the corner of Angela Court and often also parking in our cul de sac on Galli Court, where we have our driveway. As noted in the presentation, the cars block our walkway, our mailbox and make it difficult to drive out of the cul de sac when they park on the corner of the street.

We object to the proposal of having parking restrictions only within one block of the high school, as that simply pushes the parking down to our house and to our neighbors homes which is not fair. We all bought our homes with knowledge that we were close to the high school. We think a better solution is for the high school to provide adequate parking for staff and public transportation options for students and staff. The school has more than doubled in enrollment since we bought our home and has not adequately created appropriate infrastructure for the increased enrollment. Perhaps they should find off site parking and offer a shuttle bus?

Also, for all homes within walking distance of the high school, Los Altos City could provide for permitted parking spaces for residential parking only during school hours, with marked parking spaces, leaving room for walkways, mailboxes and commercial vehicles who need access such as gardeners, cleaning services and other service providers.
