A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS AUTHORIZING THE CITY MANAGER TO TERMINATE A CONSTRUCTION CONTRACT WITH APS ENVIRONMENTAL, INC. FOR SANITARY SEWER VIDEO INSPECTION, PROJECT WW-01011 IN AN AMOUNT NOT-TO-EXCEED \$303,396.76 AND TO REJECT ALL BIDS SUBMITTED FOR THE SANITARY SEWER VIDEO INSPECTION, PROJECT WW-01011

**WHEREAS**, the City bid the project, which consists of performing cleaning and television inspection of an approximate total quantity of 116,964 linear feet of various sanitary sewer lines ranging in size from 6 inches to 24 inches; and

**WHEREAS**, APS Environmental, Inc. appeared to be the lowest responsible, responsive bidder for the Project among a total of six (6) bids that were opened; and

**WHEREAS**, the contract in an amount of \$303,396.76 was awarded to APS Environmental, Inc. on June 11, 2024 and executed on August 8, 2024; and

**WHEREAS**, APS Environmental notified the City on August 20, 2024, and again on September 24, 2024, that the equipment used for the video inspection cannot provide audio recording of the information contained in the inspection logs as noted in Technical Provision 23-03.02.05.01; and

**WHEREAS**, the City determined that APS Environmental is a non-responsive bidder due to the inability to comply with Technical Provision 23-03.02.05.01; and

**WHEREAS**, the project is categorically exempt from review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301(b), involving the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public sewerage involving negligible or no expansion of existing or former use, and none of the circumstances stated in CEQA Guidelines Section 15300.2 applies.

**NOW THEREFORE, BE IT RESOLVED**, that the City Council of the City of Los Altos hereby:

- 1. Authorizes the City Manager to terminate a Construction Contract in an amount not-to-exceed \$303,936.76 to perform the Sanitary Sewer Video Inspection, Project WW-01011.
- 2. Authorizes the City Manager to reject all bids submitted for the Sanitary Sewer Video Inspection, Project WW-01011.
- 3. Directs staff to rebid project.
