### **Purpose**

To fill existing or upcoming, due to expiration of terms, Commission vacancies.

### **Background**

The City Council appoints individuals to serve on the various City Commissions and one Committee.

Except for Senior and Youth Commissioners, members are appointed to four-year terms and may serve a total of two consecutive terms plus the fulfillment of an unexpired term should they be so appointed.

### **Discussion/Analysis**

Currently there are eleven (11) vacancies total across five (5) Commissions resulting in the following Commission seats to be filled:

Parks and Recreation Commission: One partial term expiring in March 2025

Design Review Commission: Two terms expiring in September 2026

Planning Commission: Three terms expiring in September 2026

Historical Commission; Four terms expiring in September 2026

Public Arts Commission: One partial term expiring in September 2025

On August 30, 2022, the City Council interviewed all but one of the applicants.
