A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS FOR AWARD OF CONSTRUCTION CONTRACT FOR ANNUAL STREET RESURFACING AND CITY ALLEY RESURFACING PROJECT AND AUTHORIZATION TO AMEND THE FISCAL YEAR 2022/23 CIP BUDGET

WHEREAS, the Annual Street Resurfacing and City Alley Resurfacing Project includes the annual scope of work to resurface Los Altos streets and alleys and integrates mobility enhancements to improve safety for all modes of transport, with an emphasis on safer routes to schools.

WHEREAS, all work supports the Council Priorities of Community Safety and Asset Management; and

WHEREAS, on July 20, 2022, the City advertised the Annual Street Resurfacing and City Alley Resurfacing Project for bidding; and

WHEREAS, on August 11, 2022, the City received and opened three (3) bids in a public virtual session; and

WHEREAS, the FY 22/23 Council-approved CIP budget has adequate funding to fund the project.

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of Los Altos hereby adopt a resolution to:

- 1. Award the Base Bid, Additive Alternate No. 2, and Additive Alternate No. 3 for the Annual Street Resurfacing and City Alley Resurfacing Project to O'Grady Paving, Inc., and authorize the City Manager to execute an agreement with O'Grady Paving, Inc. in an amount not to exceed \$6,006,256,
- 2. Authorize the City Manager to execute change orders up to 15% (\$900,938) of the construction contract,
- 3. Authorize the City Manager to take such further actions as may be necessary to implement the foregoing agreement, and
- 4. Authorize the Interim Finance Director to amend the FY 2022/23 CIP budget, as follows:
 - a) transfer \$51,069 from CIP TS-01001 (General Fund) to CIP TS-01003
 - b) transfer \$49,261 from CIP TS-01001 (General Fund) to CIP TS-01009
 - c) transfer \$50,000 from the Traffic Impact Fee budget in CIP TS-01007 to the Vehicle Registration Fee budget

- d) transfer \$163,851 from the Traffic Impact Fee budget in CIP TS-01022 to the Vehicle Registration Fee budget
- e) transfer \$300,000 from the Traffic Impact Fee budget in CIP TS-01060 to the Vehicle Registration Fee budget
- f) appropriate \$930,672 in unallocated Gas Tax funds into CIP TS-01001
- g) appropriate \$310,180 in unallocated SB1/RMNA funds into CIP TS-01001
- h) appropriate \$581,815 in anticipated Measure B funds, into CIP TS-01001
