Dear Mr. Flores:

As prescribed by Section 6.03 of the Property Tax Code, enclosed you will find the **“OFFICIAL BALLOT”** with the candidates’ names in alphabetical order. The number of votes you are authorized to cast in the election for the Board of Directors of the Cameron Appraisal District is **12**.

Two (2) Board Directors are elected by vote of the eligible taxing units that participate in the District, which governs the Cameron Appraisal District. The governing body of each eligible taxing unit may cast all its votes for one (1) candidate or distribute the votes among any number of candidates. Each voting unit shall determine its vote by written resolution and submit it to the Chief Appraiser **BEFORE DECEMBER 15<sup>th</sup>**. Please note that there is no provision for write-in candidates. Therefore, any vote cast for someone not listed on the ballot will be discarded.

The Chief Appraiser will count all timely submitted votes, declare the two (2) candidates that receive the largest cumulative vote totals elected, and submit the results before **December 31<sup>st</sup>** to the governing body of all taxing units in the District and to the candidates.
