**WHEREAS**, the Rio Grande Valley and Cameron county is known for its favorable climate, beaches, bountiful nature and countless outdoor activities; and

**WHEREAS**, while there are venues that allow for live music and athletic events in the Rio Grande Valley, there are currently no venues that accommodate large music and athletic events in Cameron County; and

**WHEREAS**, the city council of the city of Los Fresnos recognizes that improving in the quality of life for our community benefits all within the region and county by providing those economic assets necessary to attract businesses and industries interested in locating to our area; and

**WHEREAS**, the city council of the city of Los Fresnos supports the initiative of bringing a multi-purpose arena to Cameron County that can be enjoyed by both local residents and visitors alike; and

**WHEREAS**, Cameron County would utilize the 2016 voter approved sports and community venue tax, TIRZ funding and public-private partnerships to fund the construction of a new multi-purpose arena at no cost to the taxpayers of Cameron county; and

**WHEREAS**, such a planned venue can provide a focal point for many activities, taking advantage of partnerships between educational institutions, governmental entities and private parties; and

**NOW, THEREFORE, WE THE MEMBERS OF THE CITY COUNCIL** of the city of Los Fresnos, Texas, by virtue of the authority vested by the charter of said city (town), and on behalf of the residents of our community, whole-heartily endorse the "Cameron County venue arena project" as a quality of life project that will benefit all the people of our area, and we support the voter ballot initiative that adds this visitor venue tax supported project to the list of already completed and successful projects that currently serve our community.
