MOTION: Motion by Council Member Ristow to temporarily suspend the restriction on Commissioners serving on non-profit boards that receive Town funding. **Seconded by Vice Mayor Moore.**

VOTE: Motion passed unanimously by a roll call vote.

Due to time constraints, the Mayor requested the scheduling of another study session to continue the discussion on the Board and Commission Code of Conduct Policy.
