### SECOND AMENDMENT TO AGREEMENT FOR SERVICES

Compensation for services for the dates December 30, 2024, to December 29, 2025, shall be the original agreement amount of \$66,355.59, increased by \$11,448.72 pursuant to the First Amendment, for a total agreement amount not to exceed \$77,804.31. No additional compensation is authorized by this Second Amendment.
- 3. All other terms and conditions of the Agreement remain in full force and effect.
