Dear Property Owner,

Your property is located in the designated Wildland Urban Interface (WUI) Hazardous Fire Area which required defensible space to be maintained around all structures on your property. Defensible space is the buffer created when combustible vegetation is removed or reduced around a structure to slow or stop the spread of wildfire. On February 14, 2025, Santa Clara County Fire Department mailed to you a letter regarding the enforced applicable wildland fire safety regulations and this year's property inspection schedule mandating compliance of the enforced applicable wildland fire safety regulations before **June 1, 2025**.

Your property was recently re-inspected by the Santa Clara County Fire Department on **05/06/2025**. At that time, your property was found to be non-compliant with the applicable wildland fire safety regulations. The noted violation details are listed below:

- [X] Create 30 feet of Defensible Space around the home. To accomplish this, you must clear all flammable vegetation a minimum of 30 feet (or to the property line) around structures.
 - Limb up trees 6ft from ground.

Comments or Suggestions: 1. Remove accumulated saw dust in the backyard created by the removal of a Eucalyptus tree.

2. Remove foliage, saw dust, and miscellaneous combustible items stored under the backyard deck.

On May 20, 2025, the Los Gatos Town Council passed a resolution declaring that hazardous vegetation (brush) growing to such size and such type in such locations as to constitute a fire hazard to the community may be declared a public nuisance which must be abated by the removal of said hazardous vegetation. For further particulars, please refer to said resolution.

We are informed by the Town of Los Gatos that the Los Gatos Town Council will hold a public hearing at the Town Council meeting on **Tuesday, June 17, 2025 @ 7:00 pm**. At that time, all properties identified by the Fire Department as being non-compliant with the applicable wildland fire safety regulations will be declared to have hazardous conditions requiring abatement. An additional inspection of all identified properties will be conducted after the hearing and prior to ordering any abatement work.

If you do not bring your property into compliance, the Town of Los Gatos through its contractor, may perform any brush or weed removal at your expense and will be placed on your property tax bill for payment after legal requirements are met. TOWN OF LOS GATOS 2025 COUNTY CONTRACTOR WEED ABATEMENT FEES

Properties in the Weed Abatement Program, you will be responsible for an annual inspection fee of \$105.00 per parcel.

Please be advised that the property owner of any parcel found to be non-compliant on or after the April 1st deadline will be charged a processing fee of \$597.00 and the property will be scheduled for abatement by the County contractor. If you complete the abatement work before the County contractor performs the abatement, you will not incur further charges. Should the abatement work be performed by a County contractor, you will be assessed the contractor's charges plus a County administrative fee of \$961.00 per parcel. For those parcels requiring a warrant a fee of \$1,323.00 per parcel will be assessed.

**It is required that parcels be disced twice a year. The cost for the first discing is higher due to additional work normally required during the first discing.
