Dear City Clerk Wood:

The petition named above was submitted to our office on August 17, 2022 and contained a raw count of 3,417 signatures. Pursuant to your request, 10% of the number of registered voters for the Town of Los Gatos, per the April 13, 2022 Report of Registration would equal 2,198 valid signatures to pass.

Your jurisdiction requested that the Registrar of Voters' Office conduct signature verification on the petition. The Registrar of Voters' Office verified the necessary number of signatures filed in accordance with Elections Code Section 9115.

The signature verification process resulted in the verification of 500 signatures of which 445 signatures were found valid. In accordance with California Administrative Code 20530, the petition has a projected number of 2,961 estimated valid signatures.
