**MOTION:** Motion by **Council Member Rennie** to go with staff's recommendation [listed in the memo, that Commissioner's involvement in the project should be in their personal capacity and not on behalf of the DEI Commission or Town, that third party leads the project, staff will publicize it and provide Town facilities for the final product to be displayed]. **Seconded by Vice Mayor Ristow.** **AMENDMENT:** to include that the final product be checked and is a true transcription and not an interpretation, and that an interpretation will not be displayed.
