I support the proposed Pedestrian & Bicycle elements of the project at 16212 Los Gatos Boulevard. I believe the improvements proposed by the developer substantially improve the safety of pedestrian and bicycle movement in the vicinity of the project without compromising the safety of automobile travel.

As Maria Ristow points out in her letter on this subject:

"The project will be implementing some important and costly improvements set out in the town's Bike and Pedestrian Master Plan. This intersection is a critical location for hundreds of school children who bike and walk to school. Local residents also utilize the crosswalks and bike lanes. Moving the LGB crosswalk, eliminating the slip lane and right-turn pork-chop island will make this entire intersection function better for all users. These improvements are called out in the town-funded (*and adopted*) Safe Routes to School study and incorporated into the Bike and Ped Master Plan, which was adopted by the Planning Commission and the Town Council in 2017. With the decision to make Safety a priority, the Town is committed to creating the new ped/bike-friendly infrastructure every time a road is paved, or a project is approved."
