Minutes of the Town Council Meeting  
Tuesday, August 18, 2026**

The Town Council of the Town of Los Gatos conducted a special meeting in person and via teleconference.

**MEETING CALLED TO ORDER AT 5:01 P.M.**

**ROLL CALL**
