



AMENDMENT

This SECOND AMENDMENT to Agreement for Services amends that certain Agreement for Services dated June 24, 2024, made by and between the Town of Los Gatos, ("Town,") and the Pacific Water Art Inc. RECITALS

- A. Town and Consultant entered into the Agreement for Services on June 4, 2024, ("Agreement").
- B. First Amendment to this Agreement on June 6, 2025.
- C. The parties desire to amend the Agreement in order to include repairs to the main control board and chemical system into the scope of services, and increase the compensation.

AMENDMENT

- A. Section 2.1 Scope of Services - is amended to add the following: Service Provider shall provide services described in that certain Proposal dated November 11, 2025, which hereby incorporated by reference and attached as Exhibit A.
- B. Section 2.6 Compensation - is amended to add the following: Compensation for Service Provider's professional services shall be increased by \$25,397.00 for a total agreement amount not to exceed \$102,853. Payment shall be based upon Town approval of each task based on Exhibit A.
- C. All other terms and conditions of the Agreement remain in full force and effect.

Pacific Water Art, Inc. proposes to replace the current chemical feeder inside the vault. The current automated system is obsolete and it's becoming a bit difficult to find replacement parts to keep it operating properly. We recommend that we upgrade to an easy tablet feeder system. This will help benefit the safety and longevity of the chlorine levels in the water. I recommend that we upgrade system before we restarted the fountain next year.
