Subject: Urgent Concerns Regarding Nicol Residence Project – Request to Speak at March 26

Planning Commission Meeting

Dear Jocelyn,

I hope this note finds you well. My name is **Apoorva Bakshi**, and I reside at in Los Gatos with my husband and our young daughter. We are also expecting our second child this May, which further heightens our concern for the safety, privacy, and livability of our home.

I am writing to raise **serious concerns** regarding the **Nicol Residence project**, currently under review by the Los Gatos Building Department. I am formally requesting to speak at the **Planning Commission meeting on March 26th at 7:00 p.m.**, and to be included on the agenda.

As a growing family, we are **deeply disturbed** by the potential impact this proposed construction poses to both the **structural safety** and **privacy** of our home. While we acknowledge every homeowner's right to develop their property, it cannot come at the expense of neighboring residents' rights to safety, security, and peace of mind.

Privacy

Our daughter has already voiced concern about losing her privacy, and this is not an abstract worry. The proposed height and orientation of the Nicol Residence would allow for **unobstructed views directly into our bedrooms, backyard, and pool area**, areas that are central to our private family life. This is an unacceptable intrusion.

We currently rely on mature **oak and olive trees** for a natural privacy buffer. These trees **must be preserved**—particularly those with canopies that provide vital coverage. In addition, we insist that the developer be required to add supplemental screening vegetation to protect the privacy of our home, with oversight from the Town to ensure proper execution and long-term care.

We are requesting the following changes be **mandated** as part of the approval process:

- A reduction in the proposed structure's height to eliminate direct sightlines into our private spaces
- 2. Preservation of all mature privacy trees currently serving as visual buffers
- 3. Addition of new privacy-enhancing landscaping, to be maintained under Town supervision

We expect these issues to be taken with the seriousness they deserve. Any development that compromises the well-being of neighboring families—particularly those with young children—should not proceed without thorough revision and accountability.

Thank you for your attention to this matter. I look forward to presenting my concerns in person at the upcoming meeting.
