The Wades' project has been blocked for months by an SCCFD requirement that they spend \$4.5 million dollars building a new shared road for the benefit of their neighbors as a condition of approval for a new single-family home. This requirement is unconstitutional since it is unreasonable and completely disproportionate to the project being proposed. It also constitutes a regulatory taking without compensation since the value of their property will be severely diminished if they are not able to develop it.
