Dear Los Gatos Planning Commission,

I am writing to you to express my concerns with the proposed development of 110 Wood Road due to the potential habitat destruction and impact it may have on the very animals our town is named after.

Originally named El Pueblo de Los Gatos (the town of the cats), the town was renamed in 1839 (10 years before United States statehood) to La Rinconada de Los Gatos - "the corner of the cats" - by brothers José Hernandez and Sebastian Peralta.

Today, Los Gatos retains its name, yet its namesake is considered "at risk" due to threats from habitat loss and urban development.

The proposed development at 110 Wood Road - suggested to be increased in size by Front Porch - will significantly infringe upon the habitat of the majestic wildcats that our town borrows its name from.

Considering the potential habitat loss to some of our town's earliest residents (the wildcats), the proposed increase in size of the structure (located on a mountain lion habitat - please see attached image of a juvenile mountain lion on Wood Road in May 2022), in addition to Los Gatos's heritage; <u>I implore the Los Gatos Planning Commission</u> to not only limit the size of the proposed development, but to reduce or do away with it all together.



Hello Sean, Town Council and Planning Commision at Los Gatos,

As a 40 year resident of Wood Road in Los Gatos, I want to comment on the Meadows rebuild (aka Front Porch) for the Feb 4 meeting.

When the story poles went up for a 4 story structure, I was not upset. I have lived with the Meadows community, see their value, and have always supported them – participating in almost all their town halls. We have invited them to our homes to take pictures; we provided a drone video for their use.

When Front Porch came back with a visual rendering of a multiple 5 and 6 story campus to accommodate town requests of bulk at the front of the campus, it was disappointing to me and several other Wood residents, considering our cooperation over these last 6 years. This arrangement not only blocks residents' views but also sets a precedent for tall buildings on that end of town where there is no parking, traffic challenges with cars coming off and going onto Highway 17, beach traffic, etc, etc.

I understand from Front Porch they will be submitting the multi 6 story recommendation but will be providing a 5 story alternative (specifically to A & F). Though this is a compromise, it is still setting a height precedent at that end of town and obstructing Wood Road residents' views.



I would like them to return to a 4 story overall plan. Bulk is unavoidable – why set a precedent for 5 and 6 story buildings downtown (ie the post office imminent redevelopment). Los Gatos is a town, not a city. Put the 5 & 6 story buildings where there is less impact to downtown precedent, residents and traffic.
