#### **RECOMMENDATION:**

Adopt a resolution approving the Administrative Fine and Penalty Schedule for FY 2024/25 (Attachment 1) to continue, amend, and add certain administrative fines and penalties for FY 2024/25.

#### BACKGROUND:

"Administrative Fines and Penalties" are the amounts of the administrative fines and penalties for Town Code violations.

#### DISCUSSION:

The Administrative Fine and Penalty Schedule sets forth the administrative fine penalty amounts for Town Code violations. Attachment 1, Exhibit A contains the proposed FY 2024/25 Administrative Fine and Penalty Schedule reflecting all Town Code administrative fines and penalties (including proposed changes). An itemized list of recommended FY 2024/25 administrative fine and penalty adjustments, reclassifications, and deletions are reflected in Attachment 2 and explained below:

## Los Gatos California Fire Code

1. Changes were submitted by the Santa Clara County Fire Department. Proposing to remove four fines: 901.6, 801, 2404.6.1.2, and 2305.5. Also, several section numbers and section language have been reviewed and updated.
