RECOMMENDATION:

2024 Annual Curb, Gutter, and Sidewalk Maintenance Project (CIP No. 813-9921):

- a. Award and authorize the Town Manager to execute an agreement for consultant services for materials testing with Ninyo & Moore in an amount not to exceed \$18,555; and
- b. Authorize an expenditure budget transfer in an amount of \$18,555 from the Annual Street Repair and Resurfacing Project (CIP No. 811-9901) to the Annual Curb, Gutter, and Sidewalk Maintenance Project (CIP No. 813-9921).

REMARKS:

On May 7, 2024, Council approved award and execution of an agreement with Villalobos and Associates for the 2024 Annual Curb, Gutter, and Sidewalk project (#813-9921). For this project, there is a need for materials testing as the Town does not have its own testing laboratory.

REMARKS (continued):

On February 20, 2024, Council approved the On-Call Consultants List for Engineering and Design Support Services. Staff requested proposals from the three listed materials testing consultants on the Council approved on-call list, BSK Associates, ISI Inspection Services, and Ninyo and Moore. Three proposals were submitted, evaluated, and Ninyo and Moore was selected (Attachment 2). Services include subgrade testing, concrete sampling and testing, daily field reporting.
