SUBJECT: Authorize the Town Manager to Execute a Second Amendment to a

Consultant Agreement for Executive Recruitment Services with Teri Black & Company, LLC. in an Amount Not to Exceed \$139,500 and Authorize an Expenditure Budget Adjustment in the Amount of \$40,000 from Available

General Fund Capital/Special Project Reserve.

RECOMMENDATION:

Authorize the Town Manager to execute a Second Amendment (Attachment 1) to a Consultant Agreement for executive recruitment services with Teri Black & Company, LLC. (TB&Co.) in an amount not to exceed \$139,500 and authorize an expenditure budget adjustment in the amount of \$40,000 from available General Fund Capital/Special Project Reserve.

BACKGROUND:

In anticipation of executive retirements, the Town Council authorized the Town Manager to execute an agreement with TB&Co. on October 19, 2021 (Attachment 3). During the November 16, 2021, Council meeting, the Town Manager received additional authorization to execute a first amendment with TB&Co. for the purpose of facilitating up to three Director level recruitments (Attachment 2). Since then, the Parks and Public Works Director and Town Clerk have also submitted their resignations. Based on TB&Co.'s recent successful recruitment processes for the Town, the company was selected to conduct the Parks and Public Works Director and Town Clerk recruitments.

DISCUSSION:

The candidate pool for executive level positions is typically smaller, so it is not unusual for public sector agencies to outsource these recruitment processes to executive recruitment

DISCUSSION (continued):

search firms. Because executive search firms focus solely on recruitments, they have a vast number of contacts. They also have the resources and relationships to proactively contact candidates directly that may not be actively searching for a new opportunity and encourage those candidates to compete in a specific recruitment.

CONCLUSION:

Based on TB&Co.'s expertise related to successfully completing director level recruitments, staff is requesting authorization for the Town Manager to execute an amendment to the current agreement for services to increase the not to exceed amount to \$139,500. A budget adjustment is also needed as described under the Fiscal Impact section below.

FISCAL IMPACT:

The additional cost of \$56,000 brings the total not to exceed amount to \$139,500. The Human Resources Department can absorb \$16,000 of the \$56,000 based on the Adopted FY 2021/22 Operating Budget and remaining \$40,000 is needed from the available balance in the Town's Capital/Special Projects Reserve.

ENVIRONMENTAL ASSESSMENT:

This is not a project defined under CEQA, and no further action is required.
