SUBJECT: Receive a Report from the Community Health and Senior Services  
Commission Regarding Progress on Year-One Goals of the Senior Roadmap,  
and Provide Direction on Year-One and Year-Two Goals

**RECOMMENDATION:**

Receive a report from the Community Health and Senior Services Commission (CHSSC) regarding progress on year-one goals of the Senior Roadmap, and provide direction on year-one and year-two goals.

**BACKGROUND:**

On February 7, 2023, the Council endorsed the Senior Roadmap (Attachment 2) that was prepared by the former Senior Service Committee. On March 7, 2023, the Town Council took a number of actions pertaining to the Roadmap, which included directing the CHSSC to take a lead role in implementing the year-one priorities from the Senior Roadmap as shown in Attachment 3, while referring the transportation items to the Complete Streets and Transportation Commission and deferring the housing items until after certification of the Housing Element.

**DISCUSSION:**

In Fiscal Year 2023-24, the CHSSC began their work on the year-one goals contained in the Senior Roadmap. On June 11, 2024, the CHSSC approved the attached report (Attachment 1) developed by the CHSSC to document its work during this time. The report also includes informational reports produced by key service provider organizations.
