Dear Los Gatos Town Planning Commission,

I urge you to consider including a below-market residential unit designated for a teacher in the Los Gatos-Saratoga Union School District. One of the hallmarks of our town is the deep commitment our teachers have to both their students and the broader community. Their participation in local events and engagement with families make Los Gatos a truly special place.

However, with the rising cost of living, many young educators are forced to commute long distances or choose to teach in districts where they can afford to raise their families. Offering affordable housing would help attract and retain talented teachers who want to live in and contribute to our town. Investing in teacher housing is an investment in the future of our schools and the community as a whole.

There is also precedent for designating below-market residential units in town. The North 40 project included such housing, reflecting Los Gatos' recognition of the need for affordability. Expanding this effort to support educators would reinforce our town's long-standing commitment to education and the teachers who help shape the next generation. Providing housing for our educators ensures that Los Gatos remains a place where excellent schools and a strong sense of community go hand in hand.
