SUBJECT: 31 University Avenue/PD-25-001

DATE: October 16, 2025

BACKGROUND:

On October 7, 2025, the Town Council considered and voted unanimously to introduce an Ordinance modifying Planned Development Ordinance 2025 to allow modifications to Building E at 50 University Avenue (Old Town Center).

The Planned Development Ordinance 2025 references the address of 50 University Avenue, which includes all properties associated with the Old Town Center development. The applicant for the PD modification is located at 31 University Avenue (APN 529-02-044), Building E, a building located within the Old Town Center.

The Ordinance will amend the Planned Development Ordinance 2025 to remove the following requirements that Building E:

- Design structure to appear to be a collective of individual structures that abut each other;
- The roof design be reflective of the individual structures (break-up rooflines); and
- The corner tower be redesigned into a clipped corner design.

These modifications apply only to Building E, 31 University Avenue, within the Planned Development zoning and do not affect other buildings within the Old Town Center.

Adoption of the ordinance (Attachment 1) would finalize the decision. The Ordinance will take effect 30 days after its adoption.

RECOMMENDATION:

Staff recommends that the Town Council Adopt the attached Ordinance effecting the zone change (Attachment 1).

COORDINATION:

This report was coordinated with the offices of the Town Manager and Town Attorney.

ENVIRONMENTAL ASSESSMENT:

This is a project as defined under CEQA, but is Categorically Exempt, Section 15301: Existing Facilities. No significant effect on the environment will occur since the project uses an existing structure with no increase in floor area. A Notice of Exemption will not be filed.
